Susan will remind Travis H. to remove the platforms attached to the posts under the sign as they are no longer needed.

The board will review Appendix A in the Emergency Response Plan annually and the whole plan every three years to coincide with board elections.

In the event of an emergency the OPP will be called when necessary.
